

CONTRIBUTORS

John Algeo (Department of English, University of Georgia, Athens, GA 30602) is a past president of the American Name Society (1984). His current research in neologisms and Briticisms. In collaboration with Allen Walker Read, he is editing a dictionary of Briticisms, based on the historical citation file gathered by Read over a fifty-year period and supplemented by Algeo's file of contemporary citations for words used in distinctive ways in the United Kingdom.

Irving Lewis Allen (Department of Sociology, University of Connecticut, Storrs CT 06268) teaches urban studies and the sociology of language. He is the author of *The Language of Ethnic Conflict* (Columbia University Press, 1983) and is now completing a project on historical images of New York and of city life in popular speech, 1850-1950.

Leonard R.N. Ashley (English Department, Brooklyn College CUNY, Brooklyn, NY 11210) has served two terms as president of the American Name Society (1979 and 1987). In addition to extensive onomastic contributions he has written on popular culture in the Elizabethan period, English drama, superstition and magic, and witchcraft. Two books are scheduled for publication in 1989: *What's in a Name* (a popular survey of onomastics), and *Norden: The Folklore of Norway, Sweden, Denmark, Finland, Iceland, Greenland, and The Faroes*.

Russell Brown (Department of Germanic and Slavic, SUNY at Stony Brook, Stony Brook, NY 11794) teaches modern German and comparative literature. He has written extensively on German writers, including a book on Hans Henny Jahnn's *Fluss ohne Ufer* (1969). He has read onomastic papers at American Name Society and Conference on Literary Onomastics meetings. His article on names in Elmer Rice's *The Adding Machine* appeared in *Names* in 1986.

Frederic G. Cassidy (DARE, 6125 Helen White Hall, Madison, WI 53706) is an emeritus professor of English at the University of Wisconsin, Madison, and a past president of the American Name Society (1980). He was born in Jamaica. He is the editor-in-chief of the ongoing *Dictionary of Regional American English (DARE)*, Volume 1 of which appeared in 1985. The inspiration for his exemplary onomastic study, *The Place-Names of Dane County, Wisconsin* (1947), came from his discovery of Allen Walker Read's work in Missouri placenames.

Robert F. Fowkes (632 Van Cortlandt Park Avenue, Yonkers, NY 10705) is Professor Emeritus of Linguistics and Germanic Languages, New York University, and a former president of the International Linguistics Association, at whose founding (as the Linguistic Circle of New York) he and Allen Walker Read were both present. He has published extensively in linguistics journals and has taught, among other subjects, Sanskrit, Gothic, Hittite, Celtic, Baltic, and Old Irish. Some of his teaching has been after his official retirement.

Thomas J. Gasque (Department of English, University of South Dakota, Vermillion, SD 57069) is in his first year as editor of *Names*. He continues to write on the names of the Dakotas. During the 1988-89 academic year he is at the University of Oldenburg in West Germany, on a Fulbright-supported faculty exchange.

Eric P. Hamp (Department of Linguistics, University of Chicago, 1010 E. 59th Street, Chicago, IL 60637) has done extensive work in historical and areal

linguistics and in dialectology. His specialties include Indo-European, Ancient Classical World, Celtic, Balkans, Baltic, Caucasus, and Native North America. He likes to integrate onomastics into these activities, especially extracting grammar from names.

Kelsie B. Harder (Department of English, State University College, Potsdam, NY 13676) is a past president of the American Name Society (1982) and a member since 1954. He was executive secretary for most of the years between 1960 and 1979 and was editor of *Names* in 1967 and 1968 and again from 1982 through 1987. His onomastic contributions include *Illustrated Dictionary of Place Names, United States and Canada* (1976), and he is at work on a study of placenames in St. Lawrence County, New York.

Paul L. Leslie (Department of Sociology, University of North Carolina, Greensboro, NC 27412) has as his research interests, in addition to nicknames, Southern black professional women, the effect of alcohol on sexual assault, and influence of religion on alcohol and drug abstention.

W.F.H. Nicolaisen (Department of English, General Literature, and Rhetoric, State University of New York, Binghamton, NY 13901) is a former president of the American Name Society (1977) and a member of the Executive Committee of the International Committee of Onomastic Sciences. In addition to his extensive research and numerous publications in onomastics, especially in the theory of names, he is also active in folklore research and is currently president of the Middle Atlantic Folklife Association.

Alan Rayburn (5 Solva Drive, Nepean, Ontario K2H 5R4, Canada) is a past president of the American Name Society (1985) and former executive secretary (until 1987) of the Canadian Permanent Committee on Geographical Names. He has written extensively on Canadian toponymy and has a regular column on placenames for *Canadian Geographic*, published six times a year with a circulation of 220,000 he is now a consultant in history, geography, toponymy, and genealogy.

Adrian Room (173, The Causeway, Petersfield, Hampshire, GU31 4LN, England) has written a number of books on the origins of words and names. His most recent is *Dictionary of Place-Names in the British Isles* (1988) and his next, due out in March 1989, is *Dictionary of World Place-Names Derived from British Names* which includes the origins of many U.S. and Canadian names, among others. Other onomastic areas covered by his books include pseudonyms, classical personal names, coin names, and astronomical names.

James K. Skipper, Jr. (Department of Sociology, University of North Carolina, Greensboro, NC 27412), has published several books and many articles on medical sociology, deviant behavior, and popular culture. He is past editor of the journal *Sociological Inquiry*, past president of the Mid-South Sociological Association, and president-elect of Alpha Kappa Delta, the international Sociology Honor Society. His major onomastic interest is nicknames, and he is currently preparing a book on the topic.

Roger W. Stump (Department of Geography and Planning, State University of New York, Albany NY 12222) has as his primary academic specialty the cultural geography of North America, and most of his research has focused on the geography of religion. He recently served as guest editor for a special issue of *Journal of Cultural Geography* devoted to this topic. He also has a strong interest in toponymy and, more generally, language and dialect.
