Abstract

This is a supplement to Richard B. Sealock, Margaret M. Sealock, and Margaret S. Powell, Bibliography of Place-Name Literature, United States and Canada (3rd ed., Chicago: American Library Association, 1982). The present bibliography contains 655 individual bibliographic citations arranged geographically representing the current literature from 1980 to 1988 and significant earlier works not found in the Bibliography.







In 1948 Pauline Seely and Richard B. Sealock published a modest bibliography of placename literature and in the early 1960s began to list additional items as a regular feature of Names. A second edition of their bibliography appeared in 1967, and a third, now with Margaret M. Sealock and Margaret Sealock Powell, appeared in 1982. Unfortunately, the practice of updating the bibliography in this journal did not continue after the third edition, although the collection and annotation of new items did not cease. The present list is an attempt to bring together everything that could be found up until the recent past. The compilers hope to continue to collect and annotate in anticipation of a fourth edition. They prepared this bibliography on a Macintosh computer and furnished camera-ready copy for publication; type style and typographic conventions thus vary slightly from other articles in this issue.
