Award for Best Article in NAMES

At its annual meeting in San Francisco January 8–11 2009, the American Name Society agreed to provide an annual award for the best article in *NAMES*. The award for best article in *NAMES* for volume 60 (2012) will be announced at the annual meeting in Boston, MA (January 3–6 2013).

The Award Committee for 2011 consists of the following people:

- 1. Michael F. McGoff, Binghamton University, SUNY
- 2. John Algeo, University of Georgia (Professor Emeritus)
- 3. Kemp Williams (IBM)

The Award Committee operates completely independently of the Editor. The award is given to only one article per year. The decision of the Award Committee is final. The criteria include: (1) the significance of the article, and (2) the significance of the article to the science of onomastics.

The award consists of a plaque that reads as follows:

Bibliographic Citations for Websites

With the advent of the Internet, website citations have become more frequent in journal articles. *NAMES* has had no explicit policy on this matter. For this reason, the Journal will use the following procedure. The following format will be used for Internet citations:

- I. Author's name (Surname, given name).
- 2. Date of document (if known).
- 3. Title of document.
- 4. Available at (insert link).
- 5. Date accessed.

A sample web citation would be as follows:

Ward, Mark. 2006. "Hi-Tech Crime: A Glossary." BBC News. Available at: http://news.bbc.co.uk/2/hi/uk_news/5400052.stm#whitehat [Accessed July 20 2012].

In the event that the document has no author, the format would be as follows:

- 1. Title of document.
- 2. Date of document (if known).
- 3. Available at (insert link).
- 4. Date accessed.

A sample web citation would be as follows:
