MINUTES OF MEETING OF BOARD OF MANAGERS OF THE AMERICAN NAME SOCIETY

A meeting of the Board of Managers (including members of the Editorial board) was held in Room 112 of Bascom Hall of the University of Wisconsin, Madison, Wisconsin, at 4:45 p.m. on September 10, 1957, immediately after the program of the Sixth Annual Meeting.

There were present the following: Bryant, Beeler, Ehrensperger, Gelb, Georgacas, Hanley, Meredith, Smith and Stewart. The President, Professor Stewart, presided. Elsdon C. Smith, as Secretary pro tem, recorded the proceedings.

The proposed, tentative budget for 1958 was read and explained and approved by unanimous vote of all present.

The suggestion was made that the Editor of NAMES acknowledge contributions by use of a printed two-cent post card.

The question was brought up whether the American Name Society should publish a work if the full cost were paid by the author. There was a discussion of the matter. The opinion of those present was that such papers should be published under the name of the American Name Society if approved by the Board of Editors.

The President reported concerning negotiations with the University of California in 1955. He explained that we were not turned down by them, but that the negotiations proceeded so slowly that a decision finally had to be made to print the journal elsewhere. There was a discussion of the financial affairs of the Society with optimism expressed as to present conditions and future prospects.

The suggestion was made by Professor Stewart that regional representatives be considered for the Society, and that they not necessarily be officers. There was a discussion of the matter.

There being no other or further business to come before the meeting, same was adjourned, on motion duly made, seconded and carried, at 5 30 p.m.

- III. The American Name Society thanks Mrs. Louise W. Hanley and Professor Frederic G. Cassidy, the Committee on Local Arrangements and Publicity, for their work in making this meeting one of the best the Society has ever held.
- IV. A motion was passed to the effect that the present wording in the By-laws, setting the annual dues at \$5.00, should be altered to read, "the dues shall be such a yearly sum as the Board of Managers shall from time to time determine."
