"Street-Naming Patterns in the Bronx"

Of the approximately 1200 street names in the Bronx, about 80% are named for people; 15% fall in the categories of Typographical Features, Events, and Other Place-Names; and 5% can be classified under Miscellaneous, which includes Animal, Vegetable and Mineral elements. Most Bronx streets which do not carry a number label are named for governors, mayors, bankers, and ball players. (20 minutes)

"Some Structural Changes in Slavic Ethonyms"

In pursuing his research on the names of Slavic nationalities, and Slavic ethonyms in general, the author discusses structural changes which can be observed in the evolution of such names, particularly with regard to the substitution of suffixes, e.g., --enino/-janino by -akto/jakto:

Poljanin - Polak 'Pole'

or morphological zeroing (dropping) of suffixes, e.g.,

Kaszubianin – Kaszuba 'Cassubian'

Srbin - Srb 'Serbian,' etc.

A special section is devoted to the name of Russians — a unique onomastic formation of the adjectival type in Slavic ethonymic material.
