Harold Rogers, Funk & Wagnalls Publishing Company "Geographical Names in Lexicography"

Variant names, spellings and pronunciations; the problems of applying lexicographical criteria to geographical names, e.g., which of several spellings or pronunciations is more correct or 'better' than the others.

Jeannette Blumengarten, Graduate School, New York University "Place-Names in Edmund Spenser"

Spenser borrowed place-names of old British history from Geoffrey of Monmouth, and he also used many place-names from mythology and the Bible. The wealth of his cultural background is thereby made apparent. He did not, except in a very few cases, invent allegorical place-names although the number of allegorical personal names he invented was legion. [Limited to *The Faerie Queene.*] [Mrs. Blumengarten remarked that she had spearheaded place-name research in Brooklyn, and added that her first onomastic term paper had later been stolen from a local library.]

Robert M. Rennick, State University College, Cortland, New York "Procedures for a Change of Personal Names in the United States"

This paper, part of a longer study of the practice of name-changing in the United States, treats of the methods by which a change-of-name may be effected in a court of law. After a brief account of the statutory foundations of Common Law and judicial procedures and a description of the judicial process itself, attention will be focused on the grounds – legitimate or otherwise – for the affirmation and denial of court petitions and some of the more memorable legal decisions in the past forty years on the right of assumption of "famous names."

Leonard R. N. Ashley, Brooklyn College (The City University of New York) "Honorifics: Pomp and Its Circumstances"

The style and titles of the rulers of Britain, from the earliest times, along with their soubriquets and nicknames, with explanations of their origins and significance.

Meredith F. Burrill, Director, Office of Geography, United States Department of the Interior "Some Next Steps in Name Standardization"

Increasing world acceptance of internationally standard geographic names based on nationally standardized forms is reflected in the new name specifications for the international map of the world on the scale of 1:1,000,000 and in the approach to name problems agreed upon at the ECOSOC-sponsored Regional Cartographic Conference for Africa.

The 1960 report to ECOSOC by the Group of Experts has been widely studied and commended, though not always fully understood.

The next steps will depend upon the action that ECOSOC takes on the convening of the proposed international conference of official name standardizers.

A survey of the variety of names given to the Rocky Mountains from the time of the early explorers until the present name was settled on. Among

those treated are Shining, Chippewayan, Yellow, Enchanted, Missouri, Oregon, Snow, Northern Andes, Columbinas, Cordilleras, Maclure, etc., with special attention to the battle between the British Stony and the voyageurs' Rocky.
