Book Review

J. B. Rudnyćkyj, A Bibliography of Writings, 1933–1963. Winnipeg, Canada, 1964. Pp. 96.

Here is a comprehensive account of the literary work of Professor Jaroslav Bohdan Rudnyékyj, of the University of Manitoba, "compiled and published by Students and Friends of the Author on occasion of the 30th anniversary of his scholarly activities 1933 to 1963." The Bibliography is most usable as it is well indexed under names, subjects, publications and languages.

Inspection discloses more than 940 different books, pamphlets, articles, addresses, necrologies, forewords, notes and reviews, all of a scholarly nature. Most of the items are in English, Ukrainian, or German, but there are a few in Belorussian, French, Italian, Polish, Russian, Portuguese, Serbian-Croatian, Slovak, and Spanish. Many items are on onomastics.

One is overwhelmed by the intellectual industry and wide learning evidenced by this bibliography. How can one man do all that? When he was president of the American Name Society in 1959 he did not neglect his duties. The Bibliography is preceded by a brief outline of his professional life.
